former chief executive at Mammoth Mountain, said McCoy died February 8th, peacefully in his sleep at his home in the eastern Sierra Nevada community of Bishop, Calif.

SKI AREAS SEEK CONGRESSIONAL RELIEF:Shuttered U.S. ski areas that are economic engines for many Western and New England states are pressing Congress for economic relief—though they'll likely need to wait for the next Covid-19 economic stimulus bill to get it. The relief will surely help, as losses approach \$5

billion for 2020 following nationwide closures. Along with ski resorts all over the country, Vail Resorts and Alterra Mountain Company closed 49 resorts. The company stated that while they are closed, the plan will be to conduct some limited on-mountain maintenance to potentially have a limited late-season opening if circumstances allow.
