### REPEAT INFORMATION: NORTHWEST SNOWSPORTS ADVOCATES - BECAUSE IT'S VITALLY IMPORTANT TO ALL OF US WHO LOVE TO SKI AND BOARD!!

In an effort to support our Northwest ski areas. NWSCC has formed a group called Northwest Snowsports Advocates. Information is accessed on the home page of the NWSCC website, www.nwskiers.org. You will find information about 9 Northwest ski areas that have asked for assistance with their plans for development, with further links describing the problems and the action needed. The Oregon and Washington areas listed are: 49° North, Anthony Lakes, Cooper Spur, Crystal Mountain, Mt. Ashland, Mt. Hood Meadows, The Summit at Snogualmie, Timberline, and White Pass. The site also has links to the NSAA Sustainable Slopes program called the "Green Room" where you can learn what our ski areas are doing to protect the environment. Linda McGavin recently wrote a letter to the Forest Service in support of Cooper Spur. Timberline and Mt Hood Meadows have been in the news for their efforts to reduce greenhouse gases by purchasing alternative energy.

Pacific Northwest Ski Areas Association has announced that Mt. Hood Meadows Ski Resort was the recipient of the prestigious Silver Eagle Award for Excellence in Environmental Education. Stevens Pass Ski Area won the Silver Eagle Award for Excellence in Water **Conservation**. Established in 1993, the Silver Eagle awards program recognizes the exceptional environmental programs of North America's ski and snowboard facilities.

In 2003-2004, Mt. Hood Meadows (MHM) continued its efforts to improve and expand the reach and impacts of its corporate sustainability initiative through a broad effort to educate and foster more sustainable behavior among employees, resort guests, and the broader community in which it does business. Working first with employees, MHM trains managers and orients new employees in sustainability objectives each fall. This is reinforced with brief motivational "sustainability tips" shared during daily briefings. To keep quests apprised of MHM's support of renewable energy, MHM created a quarterly newsletter, installed educational posters around its lodges, sponsored on-site public tours of the ski area, and hosted a series of public meetings to review development planning. In addition, MHM created the Mini-Green Tag program with the Bonneville Environmental Foundation, offering guests the opportunity to support renewable energy through donations online or at resort ticket windows. Posters at ticket windows and material in MHM's online Green Room explain that support of renewable energy is a means for guests to help offset the global warming impact of driving their vehicles to the mountain. Combined efforts to support renewable energy - those by the resort and MHM guests during the winter of 2003-2004 - prevented the production of 744 tons of carbon dioxide.

By the summer of 2000, the Stevens Pass Sewer District's Cascade Treatment Facility was beginning to show its age. With a duty to protect the pristine water quality of nearby Nason Creek, and a desire to craft a solution that would withstand the test of time. Stevens Pass pursued an entirely new wastewater treatment approach by developing and installing a membrane bioreactor (MBR) wastewater technology. Today, Stevens Pass' MBR system produces a high quality effluent - exceeding all Washington Department of Ecology requirements - and addresses important secondary objectives like simplicity of operation and accommodation of variable flows, remote sensing, and monitoring. After pioneering the use of MBR technology in a high elevation setting, and achieving very positive results, it is likely that MBR technology will be considered in the future for application at many other small and medium-sized mountain resorts, as well as at large resorts with remote wastewater treatment plants. For the first time in the awards program's history, a co-winner in this category was chosen -British Columbia's Sun Peaks Resort - for Sun Peaks' efforts to minimize its per capita water consumption.
